# Introduction

This Annual Report ("Report") has been prepared pursuant to the Continuing Disclosure Agreement ("Disclosure Agreement") executed in connection with the issuance of the Improvement Area ("IA") C 2003 Special Tax Bonds ("Bonds") of IA C of Community Facilities District ("CFD") No. 10 of the Poway Unified School District ("School District") in the amount of \$3,000,000 on October 16, 2003. The Bonds were issued under the Mello-Roos Community Facilities Act of 1982, as amended ("Act"), and pursuant to the Bond Indenture dated September 1, 2003 by and between the School District on behalf of IA C of CFD No. 10 and Zions First National Bank ("Fiscal Agent"). Dolinka Group, LLC has been retained by the School District to act as Dissemination Agent ("Dissemination Agent"). The Bonds were issued (i) to finance, either directly or indirectly the acquisition and construction of certain school and road improvements ("Facilities"), (ii) to fund a reserve fund for the Bonds, (iii) to pay interest on the Bonds through September 1, 2004, (iv) to pay certain administrative expenses of the CFD, and (v) to pay the costs of issuing the Bonds. All capitalized terms not defined herein shall have the meaning ascribed to them in the Disclosure Agreement.
